Outline of the Research

Aims

This research project aims (1) to investigate the current state and mechanism of social well-being in contemporary East and Southeast Asia by conducting cross-national questionnaire surveys in this region and (2) to form an international research consortium consisting of universities and institutes in the region for academic exchange on social well-being and other related studies.

Well-being, or the quality of life, has been one of the central themes in the field of social sciences. It relates not only to the socio-economic status of each individual such as income, employment, and education, but also to his or her social relations such as families and neighbors as well as to other social institutions such as the political system and religion. Therefore, in this project, we focus on the concept of social well-being rather than individual well-being to be explored both theoretically and empirically through inter-disciplinary approaches in social sciences including economics, sociology, and political sciences.

East and Southeast Asia is an attractive research area for exploring these themes because of its vast diversity in economic standard, political system, ethnicity, culture, and religion. The region also shares the historical trajectories of late-departed, thus quite rapid modernization, and the resulting social issues including sustainable economic development in the globalized market economy as well as sustainability in social security systems under low fertility rates. Therefore, this research project would contribute to expanded and deepened insight into social well-being for global academia in social sciences.



The four main activities of this project are as follows.

(1) Cross-national Questionnaire Surveys

Questionnaire surveys on social well-being entitled, "International Comparative Survey on Lifestyle and Values," are conducted in seven East and Southeast Asian countries. These surveys are designed for cross-national comparisons, so the main parts of the questionnaire are common in every country. The sample size varies by country, ranging from 1,000 to 10,000 and the respondents are distributed nationwide in each country.

(2) Symposia and Conferences


Symposia (when held in Japan) and conferences (held in other countries) are the first media to deliver our research outcomes for academics, students, policy makers and the public. We are holding symposia and conferences twice a year from 2016 on.

(3) English Journals

Annually published journal in English, *The Senshu Social Well-being Review* is the second platform to publish the findings on social well-being for mainly professional academic audience all around the world. The contents of the journal are published online at Senshu University Institute Repository, so everyone can access them freely.

(4) Japanese Journals

The Journal of Social Well-being Studies is also published annually in Japanese. It is mainly for graduate and undergraduate students, and the public in Japan who are interested in social well-being and related issues. This journal is also published online and is available free of charge.




Outcomes of this project are often presented at international academic conferences in various fields and also published on referred journals worldwide. See the section on Selected Research Outcomes for further details.
